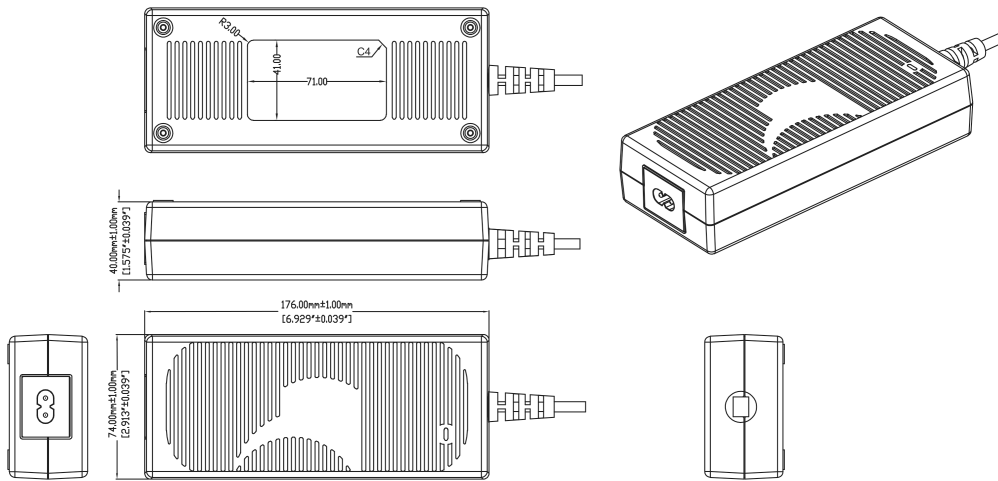

DERATING CURVE

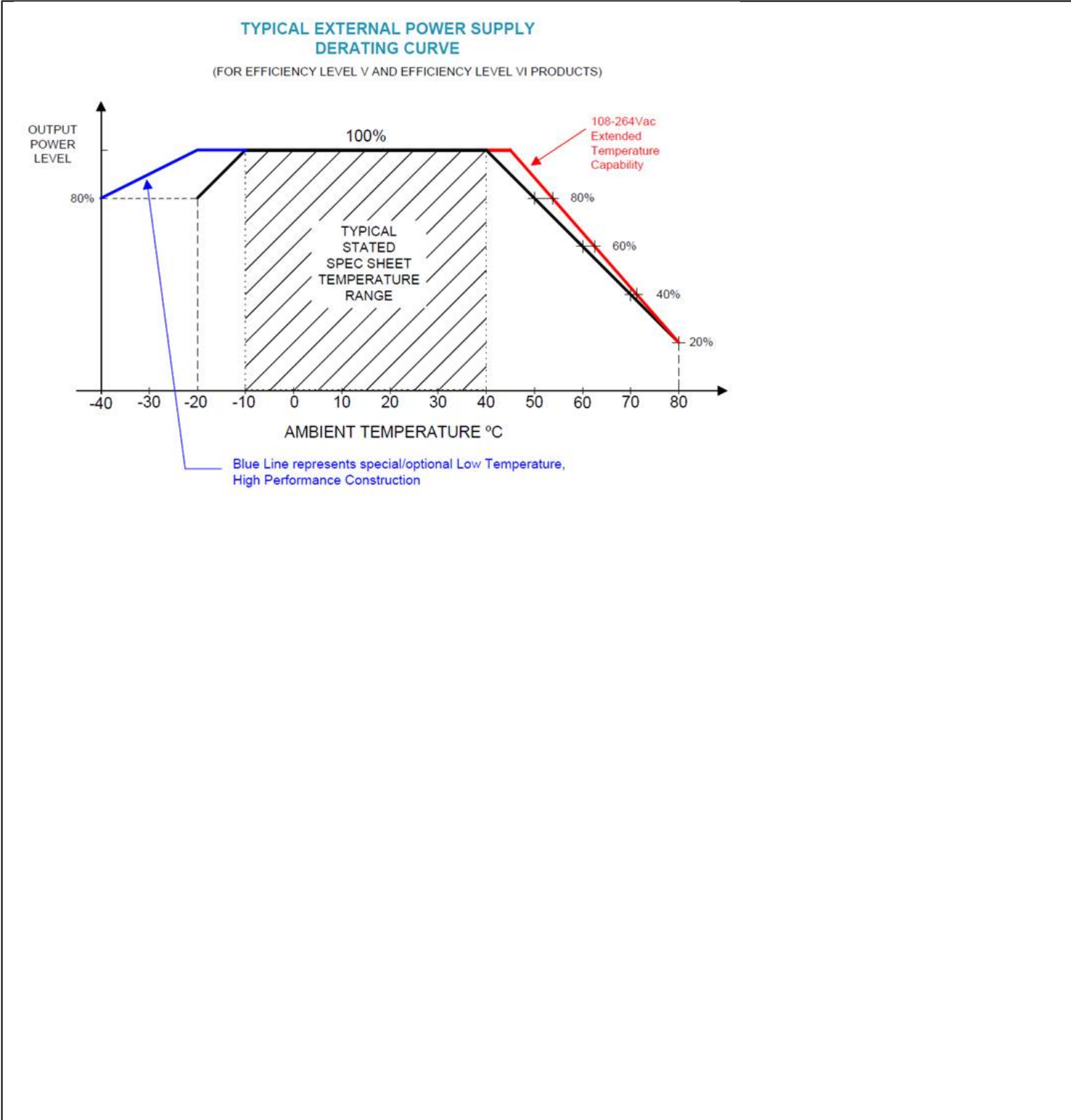

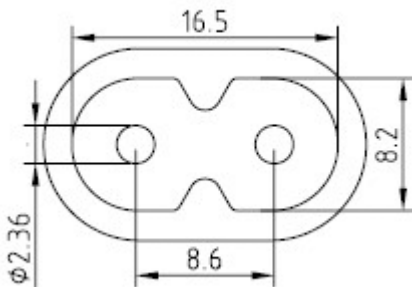
